NDSL Club Licence

The Club Licence will come into force for season 2014/2015

In order to grant the licence to your club you need the following:

The Club

1. A democratically elected committee at your A.G.M.
2. They must meet with the sports guidelines for Child Protection
3. Club Constitution & Rules
4. Email address and a club phone number
5. Club Current Account
6. A minimum of 2 11-a-side teams and 2 Development Teams
7. Public Liability Insurance

Facilities

1. All pitches to be marked up to the league's standards
2. All goal post fittings must be up to standard under FAI rules
3. Clubs must be in a position to safeguard visiting teams and officials

General Regulations

1. Register club colours i.e. jerseys, knicks & socks including a second strip
2. Club gear 1 – 20 all in regulation
3. Correct equipment as in balls, first aid kits etc. etc.
4. All managers must have at least kick-start 1
5. The club must have one coach with a minimum qualification of youth badge

The Licence will be withdrawn if the league feels the behaviour of the club is not acceptable. The application for the club licence will be sent to each club in order for you to complete and return to the NDSL office. Failure to do so will result in the club refused permission to play football in the NDSL

The Club Licence will be for a period of 2 years, however, the committee have the option to withdraw the licence at any stage.
